God had other plans, but politics and public service will miss Pat Lindsey."

GAS TAX REFUND FILING DEADLINE IS MARCH 31

MONTGOMERY, Ala. -- Farmers have until March 31 to file claims for their state gasoline tax refund, according to the Alabama Department of Revenue which also reminds farmers of new filing guidelines.

According to ADOR, a recent change in the law affecting the latter part of the 2008 refund claim year allows Alabama farmers transporting biomass to electricity-generating facilities to receive a fuel tax refund up to \$1,000. It also extends farmers' fuel tax refund provisions to include clear motor fuel used on the farm in tractor and other farm machinery attached to tractors.

Since the 2008 refund claim year will be a transition year that requires the use of refund procedures under both old and new guidelines, ADOR says farmers will be required to file two refund claim forms for the 2008 year.

“One refund claim form will apply to taxes on gasoline purchased from Jan. 1, 2008, through Aug. 5, 2008,” explained State Revenue Commissioner Tim Russell. “The refund rate for that period is 15 cents per gallon and will only apply to the amount of gasoline that was used in tractors or any auxiliary engines attached to tractors. It will not include motor fuel.

“The second refund claim will apply to taxes on gasoline and motor fuel purchased from Aug. 6, 2008, through Dec. 31, 2008,” Russell added. “The refund rate will be 11 cents per gallon, and in addition to allowable on-farm uses, it will apply to allowable off-farm uses as well.”

Farmers who have previously filed refund claims with the ADOR were mailed forms beginning Jan. 6. Any individual qualifying for a refund may obtain a claim form by writing: Alabama Department of Revenue, Sales, Use and Business Tax Division, Motor Fuels Section, P.O. Box 327540, Montgomery, AL 36132-7540, or call (334) 242-9608.

After Jan. 15, 2009, forms will also be available at all county extension agent offices and all Alabama Department of Revenue Taxpayer Service Centers.

Reminder: PREPARATION FOR UPGRADE TO DIGITAL TELEVISION

All television broadcasting will switch from an analog signal to a digital signal at Midnight on February 17, 2009. Individuals without a satellite or cable connection will need special converter boxes to receive the new digital signal.

According to the website www.dtv2009.gov, “digital broadcasting promises to provide a clearer picture and more programming options and will free up airwaves for use by emergency responders.” Service for persons with cable, satellite or those who have televisions with digital tuners will not be interrupted. The switch from analog to digital will affect only those with analog televisions which have antennas.

However, families will not have to purchase new televisions to receive the new signal. Congress has created the **TV Converter Box Coupon Program** to aid those who wish to continue to use their analog television after February 17, 2009. The program allows people to obtain up to two coupons per household to cover the cost of purchasing a specified converter. The coupons are worth \$40 each. Between January 1, 2008 and March 31, 2009, you can request a coupon while supplies last in one of four ways:

Description

Many studies have shown that Alaska Native and American Indian women are more likely to experience sexual assault and domestic violence than are women from other racial or ethnic groups. Violence committed against Alaska Native and American Indian women can be deadly. From 1979-1992, homicide was the third leading cause of death for Indian women age 15 to 34. About 75% of these women were killed by a family member or someone that they knew. Indian tribal governments may not have the resources in place to address violence committed against Indian women as a criminal offense. Tribes may not have police officers, prosecutors, courts, or judges. Tribes that do have police officers, prosecutors, courts, and judges may need training on the special needs of women who are the victims of domestic violence, dating violence, sexual assault, and stalking. They may also need training on how they can hold offenders responsible for their violent behavior. Indian women who are victims of domestic violence, dating violence, sexual assault, or stalking may need help with locating emergency shelter and transitional or temporary housing. The children of victims may also need counseling to deal with the violence that they have witnessed. Tribes may lack the resources to provide assistance to victims and their children. The Grants to Indian Tribal Governments Program (Tribal Governments Program) was created in Title IX of the Violence Against Women Act of 2005. The Tribal Governments Program is designed to fulfill the three goals of Title IX: (1) to decrease the number of violent crimes committed against Indian women; (2) to help Indian tribes use their independent authority to respond to crimes of violence against Indian women; and (3) to make sure that people who commit violent crimes against Indian women are held responsible for their actions.² The Violence Against Women Act of 2005 also created a new grant program specifically designed to address the needs of Indian women who are victims of sexual assault. The purpose of the Tribal Sexual Assault Services Program is to help tribes establish, maintain, and expand programs and projects to directly assist victims of sexual assault. OVW made its first awards under the Tribal Governments Program in Federal Fiscal Year 2007, but did not receive appropriated funds from Congress to make grant awards under the Tribal Sexual Assault Services Program until Federal Fiscal Year 2008. The National Endowment for the Humanities (NEH) and the Institute of Museum and Library Services (IMLS) invite applications to the Digital Humanities Start-Up Grants program. This program is designed to encourage innovations in the digital humanities. By awarding relatively small grants to support the planning stages, NEH aims to encourage the development of projects that are particularly innovative and promise to benefit the humanities. In an effort to foster new collaborations and advance the role of cultural repositories in online teaching, learning, and research, this program is cosponsored by IMLS. NEH and IMLS encourage library and museum officials—as well as scholars, scientists, educational institutions, and other nonprofit organizations—to apply for these grants and to collaborate when appropriate. Proposals should be for the planning or initial stages of digital initiatives in any area of the humanities. Digital Humanities Start-Up Grants may involve research that brings new approaches or documents best practices in the study of the digital humanities; planning and prototyping new digital tools for preserving, analyzing, and making accessible digital resources, including libraries' and museums' digital assets; scholarship that examines the philosophical implications and impact of the use of emerging technologies; innovative uses of technology for public programming and education utilizing both traditional and new media; and new digital modes of publication facilitating the dissemination of humanities scholarship in advanced academic as well as informal or formal educational settings at all academic levels. Innovation is a hallmark of this grant category. All applicants must propose an innovative approach, method, tool, or idea that has not been used before in the humanities. These grants are modeled, in part, on the “high risk/high reward” paradigm often used by funding agencies in the sciences. NEH is requesting proposals for projects that take some risks in the pursuit of innovation and excellence. Digital Humanities Start-Up Grants should result in plans, prototypes, or proofs of concept for long-term digital humanities projects prior to implementation. Two levels of awards will be made in this program. Level I awards are small grants designed to fund brainstorming sessions, workshops, early alpha-level prototypes, and initial planning. Level II awards are larger grants that can be used for more fully-formed projects that are ready to begin implementation or the creation of working prototypes. Applicants must state in their narrative which funding level they seek. NEH will set aside funds for each of the two levels, and more awards will be made in the Level I category. Applicants should carefully choose the funding level appropriate to the needs of the proposed project. See Section II, Award Information, for more details. Digital Humanities Start-Up Grants support full-time or part-time activities for periods up to eighteen months. Support is available for various combinations of scholars, consultants, and research assistants; project-related travel; and technical support and services. Up to 20 percent of the total grant may also be used for the acquisition of computing hardware and software. All grantees are expected to communicate the results of their work to appropriate scholarly and public audiences. In order to facilitate dissemination and increase the impact of the projects that are ultimately developed through Digital Humanities Start-Up Grants, applicants are strongly encouraged to employ open-source and fully accessible software. Successful applicants will be expected to create a “lessons learned” white paper. This white paper should document the project, including lessons learned, so that others can benefit from the grantees' experience. This white paper will be posted on the NEH or IMLS Web site.

The program was conceived to develop and support the next generation of American independent producers. The initiative focuses on the holistic producer, who identifies, options, develops, and pitches material; champions and challenges the writer/director creatively; raises financing; leads the casting/packaging process; hires and inspires crew; and navigates the sales, distribution, and marketing arenas. 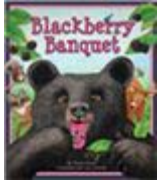

Golf Scholarships

Golf is growing more popular than ever in the United States and more students are interested in playing golf in college. However, finding and receiving USA golf scholarships is becoming quite difficult. Division I schools are only allowed to give 4.5 scholarships each year to men and 6.0 to women. The scholarships that are awarded are typically not full scholarships: the 4.5 or 6.0 scholarships are totaled, then divided and distributed to all the players on the team. The number of scholarships that are permitted decrease in Divisions II and Division III colleges are not permitted to award scholarships at all. Therefore, even if a student is able to secure a USA golf scholarship, it certainly will not be a full scholarship. Students who want a golf scholarship might find the most assistance from organizations other than their college.
